



### 1. Crashed: How a Decade of Financial Crises Changed the World/ Adam Tooze



In September 2008 President George Bush could still describe the financial crisis as an incident local to Wall Street. In fact it was a dramatic caesura of global significance that spiraled around the world, from the financial markets of the UK and Europe to the factories and dockyards of Asia, the Middle East, and Latin America, forcing a rearrangement of global governance. In the United States and Europe, it caused a fundamental reconsideration of capitalist democracy, eventually leading to the war in the Ukraine, the chaos of Greece, Brexit, and Trump.


It was the greatest crisis to have struck Western societies since the end of the Cold War, but was it inevitable? And is it over? *Crashed* is a dramatic new narrative resting on original themes: the haphazard nature of economic development and the erratic path of debt around the world; the unseen way individual countries and regions are linked together in deeply unequal relationships through financial interdependence, investment, politics, and force; the ways the financial crisis interacted with the spectacular rise of social media, the crisis of middle-class America, the rise of China, and global struggles over fossil fuels.

Finally, Tooze asks, given this history, what now are the prospects for a liberal, stable, and coherent world order?

# 2. Of Counsel: The Challenges of the Modi-Jaitley Economy/Arvind Subramanian




In *Of Counsel*: *The Challenges of the Modi-Jaitley Economy*, Arvind Subramanian provides an inside account of his rollercoaster journey as the chief economic advisor to the Government of India from 2014-18, succeeding Raghuram Rajan as captain of the ship. With an illustrious cast of characters, Subramanian's part-memoir, part-analytical writings candidly reveal the numerous triumphs and challenges of policymaking at the zenith, while appraising India's economic potential, health and future through comprehensive research and original hypotheses.

Charged with the task to restructure an insecure and fragile economy, Subramanian's trusteeship has seen the country through one of the most hotly contested and turbulent periods of economic governance and policymaking in recent decades-from the controversial recall of 85 per cent of circulated currency during demonetization to a complete overhaul in taxation with the introduction of the GST. Subramanian also addresses the overleveraging of public-sector banks, the fraught links between the state and private sector ('stigmatized capitalism'), the changing relationship between the state and the individual, and the ever-pervasive, life-threatening issues surrounding climate change.

#### 3. Gandhi: The Years That Changed the World, 1914-1948/ Ramachandra Guha




This volume opens with Mohandas Gandhi's arrival in Bombay in January 1915 and takes us through his epic struggles over the next three decades: to deliver India from British rule, to forge harmonious relations between India's Hindu and Muslim populations, to end the pernicious Hindu practice of untouchability, and to develop India's economic and moral self-reliance. We see how in each of these campaigns, Gandhi adapted methods of nonviolence--strikes, marches, fasts--that successfully challenged British authority, religious orthodoxy, social customs, and would influence non-violent, revolutionary movements throughout the world. In reconstructing Gandhi's life and work, Ramachandra Guha has drawn on sixty different archival collections, the most significant among them, a previously unavailable collection of papers belonging to Gandhi himself. Using this wealth of material, Guha creates a portrait of Gandhi and of those closest to him--family, friends, political and social leaders--that illuminates the complexity inside his thinking, his motives, his actions and their outcomes as he engaged with every important aspect of social and public life in the India of his time.

### 4. Capitalism in America: A History/ Alan Greenspan and Adrian Wooldridge



#### 5. A Complete Biography of ABRAHAM LINCOLN/ Lord Charnwood





Many of us believe our ancestors have lived in South Asia since 'time immemorial'. But, as it turns out, 'time immemorial' may not have been all that long ago.



### 7. The Jobs Crisis in India/ Raghavan Jagannathan




If you've read about self-driving cars, blockchain, and the internet of things (IoT), registered for a massive open online course (MOOC), considered dealing in cryptocurrencies, or asked Alexa to play your favourite song, the chances are you are one of the select few Indians adjusting to the reality of a brave new world driven by technology and automation. But somewhere you will also acknowledge the growing disquiet in society, where there is job-deficient growth, rising farm distress, and youths from different communities agitating for job reservations in government or the public sector. Like elsewhere on the globe, in India, too, the worlds of those with skills to handle technology, and those without, are diverging.

This book presents us with insights, explanations, and possible solutions to the aggravating jobs crisis in India. Raghavan Jagannathan comprehensively and skillfully explains the various micro and macro factors that impact the overall job scenario, including the rise of the 'gig' economy, the use of robots, new technologies and artificial intelligence (AI) that displace human labour on the shopfloor and in the services sector, and the economic uncertainties that lie ahead. Archaic labour laws designed to protect employees from exploitative employers are not helping matters at a time when capital is cheaper than ever. The world of long-term and predictable jobs and careers is shrinking. The only people who will benefit in this scenario are those who are willing to constantly upskill, relearn, and relocate to improve their job and income prospects. The world is getting older demographically, and older people always find the speed of change difficult to cope with; India, with its younger population, can do better, but government and business have not got their act together yet.

# 8. Shadows of Empire: The Anglosphere in British Politics/ Michael Kennyand Nick Pearce




The idea of an alliance between Britain and its old Commonwealth colonies has recently made a remarkable comeback in the context of Brexit. Based on belief in a special bond between the English-speaking peoples of the UK, the USA, Canada, Australia and New Zealand, it has been dubbed the 'Anglosphere' by supporters and 'Empire 2.0' by critics. In this book, leading commentators Michael Kenny and Nick Pearce trace the historical origins of this idea back to the shadow cast by the British Empire in the late Victorian era. They show how leading British political figures, from Churchill to Thatcher, consistently reworked it and how it was revived by a group of right-wing politicians, historians and pamphleteers to support the case for Brexit. They argue that, while the contemporary idea of the Anglosphere as an alternative to European Union membership is seriously flawed, it nonetheless represents an enduring account of Britain's role in the world that runs through the heart of political life over the last century. Shadows of Empire will be essential reading for everyone interested in British politics and post-Brexit foreign policy.


