NOTIFICATION

G.S.R. – In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the erstwhile Planning Commission(Technical Officer) Recruitment Rules, 1994, except as respects things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Technical Officer in the NITI Aayog, namely:-

Short title and commencement:-

- (1) These Rules may be called the NITI Aayog (National Institution for Transforming India) (Technical Officer) Recruitment Rules, 2018.
- (2) They shall come into force on the date of their publication in the Official Gazette.

2. Number of posts, classification, Level in the Pay Matrix :-

The number of the said posts, their classification, level of pay in the pay matrix applicable thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these Rules.

3. Method of recruitment, age limit, qualifications etc:-

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to 13) of the said Schedule.

- 4. Disqualification No person :-
 - (a) who has entered into or contracted a marriage with a person having a spouse living or;
 - (b) who, having a spouse living, as entered into or contracted a marriage with any other person shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- 5. Power to relax: Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect of any class or category of persons.
- 6. Savings:- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribe, Other Backward Classes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

Desirable:

Experience of supervising operation and maintenance of audio-visual aids photostat machines etc.

Note 1:-

Qualifications are relaxable at the discretion of the UPSC, for reasons to be recorded in writing, in case of candidates otherwise well qualified.

Note 2:-

The qualification(s) regarding experience is/are relaxable at the discretion of the UPSC, for reasons to be recorded in writing, in case of candidates belonging to Scheduled Castes and Scheduled Tribe, if at any stage of selection, the UPSC is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the posts reserved for them.

Note 3: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation/absorption. Similarly, the deputationists candidates shall not be eligible for consideration for appointment by Promotion.

[Period of deputation including period of deputation in another excadre post held immediately preceding this appointment in the same or some other organisations/department of the Central Government shall ordinarily not to exceed five years. The maximum age limit for appointment by deputation (ISTC) shall not be exceeding 56 years as on the closing date for receipt of applications].

Note – The proceedings of the DPC relating to confirmation of a direct recruit shall be sent to the Commission for approval. If, however, these are not approved by the Commission a fresh didates meeting of the DPC to be presided over by the Chairman or a member of the UPSC shall be held.

Circumstances in which Union Public Service Commission is to be consulted in making recruitment

Selection on each occasion shall be made in consultation with the Union Public Service Commission
