5	Period of Contract	For a period of 2 years. In case a person leaves before completion of one year, he/she will not get any work certificate
6	Remuneration (per month)	An initial consolidated amount of Rs. 60,000 per month, inclusive of Transport Allowance and all taxes.
7	Education qualification	<p><u>Essential</u></p> <p>Master Degree or B.Tech or PG Diploma in Management (2 years) or equivalent in any discipline .</p> <p><u>Desirable</u></p> <p>i. M.Phil or additional qualifications, research experience, published papers and post qualification experience in the relevant field as prescribed in the job description below.</p> <p>ii) Candidates should have good working knowledge of technology based skills on the computer and ability to work on ICT applications. 9	Job description	<p>Young Professionals (YPs) will be required to provide high quality inputs in disciplines like Agriculture/ Economics/ Finance/ Education/ Health / Nutrition/Women & Children issues/ Social Sciences/ Engineering & Technology/ Urban Planning/ Infrastructure/ Environment/ Rural Development/ Data Analysis/ Project Management/ Start Up/ Innovation etc. This would require demonstration of proven academic credentials, professional achievements and leadership qualities on the part of the aspirants.</p> <p>They may also be required to work for special task like North-East Forum and Aspirational District Program wherein they will be required to identify constraints and recommend suitable interventions for accelerated, inclusive and sustainable growth in the region. They may also be engaged to monitor and review the development status in the region.</p>
