

## ADDENDUM

1. Page number 33, serial number 1 in the table under the column experience please substitute the first bullet point with **“minimum 15 years of professional experience in advisory/consulting”**.
2. Page number 17, serial number 7.12 (vii) please substitute this point with **“Ongoing consulting assignment in which 50% payment has been received by the applicant will only be considered. For this purpose the copy of notice of award, letter of intent, proof of release of payment or a certificate issued by the Authorized Signatory to this effect should be enclosed.”**
3. Page number 22, table at 9.4 at serial number a , please substitute **“INR 3 Crore”** with **“INR 1 Crore”**. Further at serial number b (i) please substitute **“INR 30 Lakh”** with **“INR 15 Lakh”** and at b (ii) substitute **“INR 1 Crore”** with **“INR 30 Lakh”**.
4. Page number 24, table at 9.5.4, at serial number A1, please substitute **“INR 3 Crore”** with **“INR 1 Crore”**. Further at serial number A2 (i) please substitute **“INR 30 Lakh”** with **“INR 15 Lakh”** and A2 (ii) substitute **“INR 1 Crore”** with **“INR 30 Lakh”**.
5. Page number 22, serial number 9.4 b (ii), please substitute **“at least three projects”** with **“at least two projects”**
6. Page number 17, point number 7.12 (v), please substitute **“(3 sheets double sided)”** with **“(5 sheets double sided)”**
7. Page number 32, Annexure 2, the word **“as per the requirement mentioned”** in the first sentence and in the second sentence the word **“along with timeframes as indicated”** has been deleted.
8. Page number 35, 36, 37, Annexure 2 under Resource pool, the educational qualification for all the experts may be read as **“should be Post graduate in Engineering/ Masters in Business Administration/ relevant discipline”**.
9. Page number 43, in the table the words **“and Consultants for committee”** has been deleted.
10. Page number 85, II General Conditions of Contract, clause 6.5.8, the following expression **“but on terms and conditions approved by the client”** shall be deleted.
11. Page number 87, II General Conditions of Contract, at the end of the clause 6.11 following sentence shall be added **“in cases of delay due to reasons beyond the control of consultant suitable time extension shall be provided”**.

12. Page number 13, para 6.8, at the end of the paragraph the following sentence shall be added **“The sub consultants also include independent experts.”**
13. Page number 32, para 1 bullet 2, substitute with **“The consultant shall ensure that its team shall be deployed in a manner to ensure smooth coordination with authority and the concerned State Governments and that activities / tasks assigned to each team member are delivered and completed in a time bound manner. The consultant make to ensure that the absence of any team member at any point of time during the project shall not conflict with client’s requirements for project progress”** and para 3 the line **“Consultant shall ensure that services of the core team are provided full time for the contractual period”** shall be deleted.
14. Page number 33, Serial number 1, second bullet point, please substitute **“total consultancy fee of Rs. 3 crore”** with **“total consultancy fee of Rs. 1 crore”**.
15. Page number 33, Serial number 1, third bullet point, please substitute **“demonstrated experience of leading at least five assignments”** with **“demonstrated experience of leading at least three assignments”**.
16. Page number 33, Serial number 2, first bullet point, please substitute **“minimum 10 years of professional experience”** with **“minimum 8 years of professional experience”**.
17. Page number 33, Serial number 2, second bullet point, please substitute **“experience of managing at least three projects”** with **“experience of managing at least two projects”**.
18. Page number 22, S.no (a) & (b), Page number 24, S.no (A1 & A2), Page number 43, bullet number 2, Page number 59, bullet number 5, please substitute **“last five years”** with **“last seven years”**.
19. Page number 33, Serial number 1, column two, substitute **“Master Degree in Engineering / Business Administration / Economics from a reputed and recognized university or Institution”** with **“Master Degree in Engineering / Business Administration / Economics / other relevant infrastructure related discipline”** from a reputed and recognized university or Institution.
