In view of the above mentioned major deficiencies, it is submitted for information of all concerned that the technical bids of none of bidders qualify the Technical Evaluation Criteria of the tender under reference and hence the technical bids of all the Bidding Firms namely (i) M/s Pragati Engineers, (ii) M/s G H Traders, (iii) M/s Sun Enterprises & (iv) M/s Jigyasa Enterprises are summarily rejected and eTender Reference No.05/16/2018-CMU dated 27/11/2018 is declared non-responsive.
